[1] Notwithstanding Mr. Green's careful and forceful arguments on behalf of his client, the appellant, we have not been persuaded that Mosley J. of the Federal Court (2020 FC 675) erred in law or made a palpable and overriding error in refusing to compel the respondents to appear
